### **SPONSOR'S STATEMENT**

#### **Sponsor Requirement**

All applicants must be supported by at least two sponsors for professional review submission. Sponsor must understand the requirements of the professional review process and the competence for being the professional engineer. All members must be professionally qualified and registered as PEng with a minimum of three years of registration tenure or IEB Fellows with a minimum of ten years of status.

#### **Instructions for the Sponsor**

This form is to be submitted to support a candidate applying to become a Professional Engineer. The statement of support is an important part of the candidate's application. Please take the responsibility seriously and provide an effective statement to support. You must know the candidate professionally, understand the required competences of the applicant, and how they have met them. At the end, the sponsor is to declare on the statement that

"The candidate is a competent and appropriate person for being a professional engineer."

If you feel that the candidate is not competent or not in a position to become a Professional Engineer, you may decline the application. Sponsor must complete all sections of this form and provide a statement of support of no more than 600 words describing, from personal knowledge, that the candidate possesses the requisite abilities and characteristics. The sponsor must review and scrutinize the candidate's submission and be happy that it demonstrates all the competences as required by the BPERB. It is expected that you will provide advice during their preparation will be reflect on their presentation and practice interviews.

#### **Returning the Sponsor's Report**

You must complete the statement of support based upon your personal knowledge of the candidate. Under no circumstances should the candidate complete this form. You must take all reasonable measures to guarantee that the statements you have made are accurate, comprehensive, and not misleading. If this is not done, the IEB's professional code of conduct may be violated, and you, as an IEB member, may be subjected to disciplinary proceedings.

The completed sponsor report must be submitted though the online portal by uploading as soon as they received it (usually within two weeks of application). Alternatively, the sponsor may send the hardcopy in closed/concealed envelope to BPERB office.
